**Amendment to the Subject-Specific Provisions of the Master of Science
in Politics, Economics and Philosophy (MSc)
of 10 July 2013 and 23 October 2013**

On 11 November 2013 the Presidium of Universität Hamburg ratified the amendments to the Subject-Specific Provisions for the Master of Science in Politics, Economics and Philosophy dated 17 June 2009 and as amended 16 June 2010 as the subject of a degree program leading to the qualification Master of Science (MSc) pursuant to Section 108 subsection 1 of the Hamburg Higher Education Act (HmbHG), which was adopted by the Faculty of Business, Economics and Social Sciences on 10 July 2013 and by the Faculty of Humanities on 23 October 2013 in accordance with Section 91 subsection 2 number 1 HmbHG dated 18 July 2001 (HmbGVBl. page 171) and amended on 4 December 2012 (HmbGVBl. page 510, 518).

Section 1

The Subject-Specific Provisions for the Master of Science in Politics, Economics and Philosophy as the subject of a degree program leading to the qualification Master of Science (MSc) as of 17 June 2009 shall be amended by the amendments of 16 June 2010 as follows:

1. In Section 4 subsections 2 and 3, the information about modules 5 and 6 shall be deleted and replaced as follows: “Module 5: Interdisciplinary Seminars, 24 ECTS credits.” In the overview “Course Program and Modules”, the text passage “Interdisciplinary Seminar (12 ECTS credits)” in semester 2 shall be replaced with “Interdisciplinary Seminar I (12 ECTS credits).” The text passage “Interdisciplinary Seminar (12 ECTS credits)” in semester 3 shall be replaced with “Interdisciplinary Seminar II (12 ECTS credits).” Further shall be added: “2 from 3: Interdisciplinary Seminar in Politics and Economics, Interdisciplinary Seminar in Philosophy and Economics, Interdisciplinary Seminar in Philosophy and Politics.” In the overview describing the required modules, the text passages “Interdisciplinary Seminar in Philosophy and Economics” and “Interdisciplinary Seminar in Politics and Economics” shall be deleted and replaced with “Interdisciplinary Seminars, number of courses 2, total ECTS credits 24.”

2. The descriptions of modules 5 and 6 shall be deleted and replaced with the following module description for Module 5 Interdisciplinary Seminars:

Module 5: Interdisciplinary Seminars	
Objectives:	The ability to apply, synthesize, and contrast methods and findings from the three disciplines of political science, economics, and philosophy with regard to specific problems within the context of individual and collective decision-making.
Curriculum:	Students must select two of the following three courses: a) Interdisciplinary Seminar in Philosophy and Economics: Various themes relating to individual and collective decisions with a focus on integrating the disciplines of political science and economics. b) Interdisciplinary Seminar in Philosophy and Economics: Various themes relating to individual and collective decisions with a focus on integrating the disciplines of philosophy and economics. c) Interdisciplinary Seminar in Philosophy and Economics: Various themes relating to individual and collective decisions with a focus on integrating the disciplines of philosophy and political science.
Types of instruction:	Seminar (2 credit hours per week)
Language of instruction:	English
Prerequisites for participation:	None
Applicability of the module:	This module is a component of the Master of Science in Politics, Economics and Philosophy.
Type, requirements, and language of module examination (component):	The module examination consists of at least two and a maximum of three individual examinations in accordance with the catalog provided for in Section 13 subsection 4 of the Examination Regulations, whereby a term paper shall qualify as an examination pursuant to Section 13 subsection 4c of the Examination Regulations. The exact number and type of examinations shall be announced at the beginning of the course. The examination shall be held in English.
Course workload (components):	24 ECTS credits from two of the three following courses: (a) Interdisciplinary Seminar in Politics and Economics: 12 ECTS credits

	(b) Interdisciplinary Seminar in Philosophy and Economics: 12 ECTS credits (c) Interdisciplinary Seminar in Philosophy and Politics: 12 ECTS credits
Total workload of module:	24 ECTS credits
Semester in which module is taken:	Semester 2 or 3
Module frequency:	Once a year
Duration:	The entire module lasts two semesters.

Section 2

These Amendments shall become effective on the day after they are ratified by the Presidium of Universität Hamburg. They shall first apply to students commencing their studies in the winter semester 2013/14.
