Universität Hamburg Fee Bylaws for the Master of Arts (MA) / Master of Laws (LLM) in Law and Economics of the Arab Region

dated 13 July 2020

On 13 July 2020, in accordance with Section 79 subsection 2 no. 3 in conjunction with Section 6 b subsection 1 sentence 2 second alternative of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG) dated 18 July 2001 (HmbGVBI. Section 171), as amended on 24 January 2020 (HmbGVBI. Section 472), after consultation with the Academic Senate (Section 85 subsection 1 no. 13 HmbHG), the Executive University Board of Universität Hamburg adopted the fee bylaws for the Master of Arts (MA) / Master of Laws (LLM) in Law and Economics of the Arab Region at Universität Hamburg in collaboration with the Faculty of Economics and Political Science at Cairo University.

Section 1 Scope

These bylaws govern the fees to be charged for the third semester of the MA/LLM in Law and Economics in the Arab Region to be completed at Universität Hamburg, hereinafter referred to as "Degree Program" at Universität Hamburg.

Section 2 Fees

The semester fees for the Degree Program to be completed at Universität Hamburg amount to EUR 1,652.85 per participant.

Section 3 Payment obligation

Payment of tuition is obligatory for all students applying to enroll in the Degree Program at Universität Hamburg. Proof of payment of tuition fees must be submitted with the enrollment application by 1 February before commencing studies in the summer semester. Tuition fees must be settled in one payment. Any other fees and charges are listed in the fee notice.

Section 4 Refunds

- (1) An administrative fee of EUR 300.00 will be charged if an individual does not commence studies after accepting an offer of admission to the program.
- (2) Tuition fees paid for a semester will not be refunded once the semester has begun.
- (3) With respect to cases where a student has not commenced studies on account of reasons beyond the student's control, the examinations board will render a decision in consultation with and the assent of the office of the dean of the Faculty of Law at Universität Hamburg.

Section 5 Fee deferment and waiver

In cases of considerable or particular hardship, fees may be deferred or waived. Section 62 of the Hamburg state budget regulations (Landeshaushaltsordnung, LHO) dated 17 December 2013 (HmbGVBl. Section 503) apply as amended mutatis mutandis.

Section 6 Effective date

These fee bylaws become effective the day after their publication in the official government gazette. They apply to all students who begin studying in or after Winter Semester 2020/21.
