Suspension of the Subject-Specific Provisions for the Master of Science in Wood Science (MSc) dated 4 October 2017 and 3 April 2019, last amended 16 February 2022

and

Suspension of the Subject-Specific provisions for Wood Science as a subject leading to the Master of Science (MSc) dated 5 March 2008 and 10 February 2010, last amended 2 July 2014

dated 17 April 2024

On 28 May 2024, the Executive University Board of the University of Hamburg, in accordance with Section 108 subsection 1 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG), dated 18 July 2001 (HmbGVBl. p. 171), last amended on 11 July 2023 (HmbGVBl. page 468), ratified the suspension of the Subject-Specific Provisions for the Master of Science in Wood Science as well as the suspension of the Subject-Specific provisions for Holzwirtschaft leading to the Master of Science (MSc) as adopted by the Faculty of Mathematics, Informatics and Natural Sciences on 17 April 2024 in accordance with Section 91 subsection 2 no. 1 HmbHG.

Section 1

- (1) The Subject-Specific provisions for the Master of Science in Wood Science (MSc) dated 4 October 2017 and 3 April 2019, last amended 16 February 2022, will expire at the end of Winter Semester 2031/2032. The examination procedures must be completed by this date. The Subject-Specific Provisions will not apply for students commencing their studies in the Masters of Science in Wood Science (MSc) after Winter Semester 2025/2026.
- (2) The subject-specific provisions for Wood Science as a subject leading to the Master of Science (MSc) dated 5 March 2008, 10 February 2010, last amended 2 July 2014, will expire at the end of Winter Semester 2031/2032. The examination procedures must be completed by this date.

Section 2

- (1) These Suspension Regulations become effective on the day following official publication by the University of Hamburg.
